	1	<u>Apologies for absence.</u> Cllr Maine, Cllr Killen.	
	2	<u>Public Forum:</u> The Chairman will adjourn the meeting for a maximum of 15 minutes to allow public participation. No members of the public were present.	
	3	<u>Declarations of Interest:</u> None.	
	4	<u>Acceptance of the Minutes of previous meetings:</u> Resolution to postpone the acceptance of the minutes of the meeting held on 3 <sup>rd</sup> June 2015 until the meeting to be held on 1 <sup>st</sup> July. This was approved all in favour.	
	5	<p><u>Planning:</u></p> <p><b>a) Appeal re: application 2014/0784/FUL</b> – Change of use, The New Inn, Priddy. Update to objection previously lodged by Parish Council.</p> <p>Cllrs Greet and Dyke reported on a meeting held with the agents handling the sale of the New Inn. They reported that although there had been several offers, their clients did not intend to sell until the outcome of the appeal was known.</p> <p>Cllrs Greet and Dyke also reported on informal conversations held with the manager of the Queen Victoria Inn regarding current levels of trade.</p> <p>The appellants statement had been circulated and Cllr Greet had prepared and circulated a draft response to be sent to the Planning Inspector. A number of queries were raised and changes suggested. There was some discussion about the sections within the response rebutting statements made by the appellants in their statement to the inspector.</p> <p>It was agreed that Cllr Greet should amend the draft as necessary and forward electronically to the inspector on 18<sup>th</sup> June along with hard copies sent in the mail.</p>
